


Global growth rate of light cars



Stable business increasing trend showing in 6-year period table:

- Oil/Gas field downed to the bottom from Q1/2015~Q1/2017, business stable increasing from Q2/2017.
- Special bike components dramatically increased since Q4/2016 (will bring 4X revenue than 2016).
- Hydraulic system components will join the business contribution from Q4/2017 (new product launch).


The product market revenue growth rate in 2017 H1






The Revenue Growth Trend






The Revenue ratio of Product market in Globlatek
